Dear Club Member's,



A Coronary Artery CT scan measures the amount of calcium deposits in the arteries of the heart. The test takes approximately 20-30 minutes, involves a small amount of radiation exposure, and requires an IV contrast injection. Additionally, a medication to slightly slow the heart rate is administered. Otherwise, it is a quick, easy, and painless test. Recent studies have provided valuable insights into the role of CAC testing in assessing cardiovascular risk among women over 50.

One of the greatest values of CAC testing is its role in determining whether a statin is necessary based on LDL cholesterol levels. For example, if your LDL is 130 (normal is less than 100) and your CAC score is 0, focusing on diet and exercise may be sufficient. However, if your LDL is 130 and your CAC score is elevated, a statin may be recommended in addition to lifestyle changes, warranting a more aggressive approach.

Monitor and Manage Risk Factors: Maintaining a healthy lifestyle by managing blood pressure, cholesterol levels, and avoiding smoking can help slow the progression of coronary artery calcification.

Actionable Takeaways:

Consider CAC Testing: Women over 50, especially those with risk factors such as hypertension, high cholesterol, or a family history of heart disease, should discuss the potential benefits of CAC testing with their healthcare provider.

Monitor and Manage Risk Factors: Maintaining a healthy lifestyle by managing blood pressure, cholesterol levels, and avoiding smoking can help slow the progression of coronary artery calcification.

Evaluate Hormone Therapy: Postmenopausal women should consult their healthcare providers about the risks and benefits of hormone therapy in relation to heart health.

Jeannette Rankin Left A Legacy THAT CONTINUES TO HELP WOMEN TODAY By Claudia Maidenberg



Until 1922 the courts generally ruled that the alien wife of an alien husband could not herself be naturalized as citizen separately from her husband. U.S. born women often gained foreign nationality (and thereby lost their U.S. citizenship) by marriage to a foreigner. Can you imagine being part of a family that founded our country and then losing your citizenship because you married a man born in another country?


The first woman be elected to the U.S. Congress, Jeannette Rankin tried to solve this citizenship problem. In 1916 she introduced the first bill that would have allowed women citizenship independent of their husbands. Congress did not act on this bill.

Rankin used her office to push for better working conditions for laborers. She had success pushing for better working conditions in the <u>Bureau of Engraving and</u> <u>Printing</u>. The 8 hour work day we currently use as a standard is a result of Rankin's efforts to draw attention to the working conditions of the bureau. Due the information she discovered, Treasury Secretary <u>William McAdoo</u> convened his own investigation and ultimately limited the work day to eight hours.

In 1920, Rankin helped found the <u>American Civil Liberties Union</u> and served as a vice president.

Rankin died on May 18, 1973, at age 92. She bequeathed her estate to help "mature, unemployed women workers". The Jeannette Rankin Foundation (<u>Jeannette</u> <u>Rankin Women's Scholarship Fund</u>), a 501(c)(3) nonprofit organization, awards annual educational scholarships to low-income women 35 and older across the United States. Beginning with a single \$500 scholarship in 1978, the fund has since awarded more than \$1.8 million in scholarships to more than 700 women.
